At 10h00 on Saturday, 4th July 2015, the Stewards received a written report from the Clerk of the Course with attachments regarding an incident on SS2 involving car No. 42 and a spectator who was injured. The Medical Report states that the spectator had suffered an "acromio-clavicular joint separation injury" and, after examination and treatment in the hospital, he was discharged on the same day.

After studying the dossier, which comprised a report from the marshal on-site, the medical report, a report from a witness, a photo of the place and the onboard footage from car No. 42, the Stewards decided to further investigate the incident, exclusively under sporting law, and to conduct a hearing with the competitor and crew of car No. 42.

The hearing was held on Saturday, 4th July 2015, at 17h00, and attended by the driver VALERIY GORBAN, the co-driver VOLODYMYR KORSIA and their team manager ANDRUS LAUR, who also translated the statements made by the driver.


Upon being questioned, the driver stated that:

- In approaching the corner in question, he was breaking too late and went off the track towards the "red zone",
- Both driver and co-driver did absolutely not realize that they were supposed to have hit a person,
- They did not get any kind of signal by anybody on-site to stop or any kind of indication that there was any other kind of problem,
- As they considered this to be a "normal" off road, they did not see any reason why they should not continue on the special stage,
- Whilst they were reversing and turning to continue on the special stage, all persons around were on their legs and moving as normal.
- Upon being further questioned, the driver said that, when he was approaching the corner and trying to bring the car under control, he did not see any spectators at the site.


After examination of the evidence and the onboard footage, in consideration of the statements made by the crew which the Stewards considered to be credible and after deliberation, the Stewards
