Environmental Policy – ORLEN 80th Rally Poland

The Organizer of Rally Poland, in accordance with the FIA's decision to grant this event the status of a world championship in 2024, has consciously declared their commitment to conducting a responsible social and environmental policy. This will be achieved by undertaking all actions that minimize the impact of the event on the environment and participating in the Environmental Accreditation Program (FIA). At the same time, the Organizer has committed to continuous development and implementation of further ecological and pro-social solutions, the aim of which is to achieve two stars in 2024, maintain this level and then reach the level of three stars in subsequent years.

Recognizing the importance of sustainable development, limiting the impact on climate change through carbon footprint reduction, and protecting biodiversity, we aim to achieve our goal by implementing a management system for specific indicators, their monitoring, and reducing or compensating actions in case of exceedances. This is particularly important for the Rally Poland, as its routes run through a region rich in natural environment, considered the green lungs of Poland.


Carrying out actions aimed at achieving the environmental goal requires not only the engagement of the Rally Organizer's members, but also the inclusion and encouragement of ecological solutions among event partners, such as: service providers, media, local governments, and promoting appropriate attitudes and increasing awareness among competitors, staff, or fans. We care about positively influencing the local community and the sustainable development of the region through the dissemination of environmentally friendly solutions and technologies. Together we can do more.

In concern for the environment and taking full responsibility for sustainable development, we wish to implement the following actions and commit our partners to follow, in accordance with the principles below:

- 1) Compliance with national environmental laws, the PZM Environmental Protection Regulations in motor sports, and the requirements of the FIA Environmental Accreditation Program.
- 2) Promoting environmental awareness through available communication channels (rally materials, websites, media, social media).
- 3) Educating organization members, event staff, and service providers on environmental policy and good practices.
- 4) Implementing solutions that reduce energy consumption, promoting renewable energy sources.
- 5) Limiting water consumption, promoting actions that minimize the impact on the soil and water environment.
- 6) Reducing waste production, including the use of recycled packaging and materials, waste segregation, and the use of solutions that allow for their reuse.



- 7) Reducing carbon dioxide emissions from transport, through efficient transport logistics in the delivery of equipment and materials, introducing hybrid and electric vehicles to the organizer's fleet, promoting fans' travel by public transport and shared rides, maximizing online meetings.
- 8) Cooperation between all entities in the field of environmental protection for actions aimed at reducing noise and air pollution.
- 9) Limiting documents and materials in paper form, publishing materials, newsletters in electronic form, preparing official documents, if possible, in electronic versions.
- 10) Monitoring established indicators and introducing improvements based on them in adopted solutions.
